Collection Summary: This collection consists of records related to the Martin House Farm at 22 Stoney Hill Rd, Swansea, MA, under the domain of the National Society of the Colonial Dames of America in the Commonwealth of Massachusetts (NSCDA-MA). It includes history of the Martin family and of the farmhouse and surrounding land and gardens, preservation of the house and grounds, public programs, and administrative files. The NSCDA-MA is a non-profit organization that promotes our national heritage through the preservation of historic buildings and artifacts.

Collection Details

Collection Description: This collection contains documents related to the history, interior decorations, grounds, maintenance, and administration of Martin House Farm, including information pertinent to the genealogy of the Martin family. Materials include manuscripts, correspondence, drawings and plans, print materials, and photographs. The collection is currently stored in the Archives of the NSCDA-MA. This collection will be of interest to genealogists and to researchers studying the history of New England; 18th-century interiors and textiles; the occupants of the house and their families; and women's groups and women's history.

Biographical Note: In 1728, John Martin the Younger built Martin House Farm on the 63-acre lot of land which had been purchased by his father. Martin, his wife, and their eight children lived in Martin House Farm as did their descendants for more than 200 years. In 1930, eighth-generation Martin descendant Susan Taber Martin Allien bestowed Martin House Farm to the NSCDA-MA. Martin House Farm was then placed on the National Register of Historic Places in 1979.

This collection was donated to the NSCDA in 1930 by Susan Taber Martin Allien, a member of the New York Society of The Colonial Dames and a descendant of John Martin.
